MR. AMODIO: Okay. We'll start with the Executive Director's report.

Joe, if you would, please.

MR. BELLA: First thing I'd like to talk about the UASI grant. Ed has been working with bureaucracy in Trenton and so far it's going very well. They haven't actually granted the extension, but they tell us they will give us an extension.

PRESIDENT SANCHEZ: How long?

MR. BELLA: Till the end of the year.

PRESIDENT SANCHEZ: So we still have time to go out to bid the normal way.

MR. DUPREY: We have a Resolution in to the Board and, you know, we were going on the approach that in case they did not grant an

extension, we didn't want to lose the money. So our Resolution allows for the award and professional services and the award under Federal GSA for the equipment and supplies so that we could get it in place by June 30th. And right now I called the consultant this morning and they are still on track and if we receive the approval from the historic group that they would have the equipment installed by June 30th provided that that Resolution is approved at today's meeting and if we get the extension, so be it.

(Whereupon, Commissioner Rodriguez is present at 9:48)

MR. BELLA: The question is, will we have, if -- once we're granted the extension, we go through the normal bid process, vendor selection, will it be done by the end of the year?

MR. DUPREY: Yes.

PRESIDENT SANCHEZ: You don't think the pricing gets affected because we're rushing the whole thing?

MR. DUPREY: There's a couple of aspects to this. One is there's an aspect of continuity

and consistency with the Prosecutor's fiber system. That is that they, this Millineum, this is the group that has the Federal contract. They provided for fiber system with the County. Our system has to interface with that. That's part of the grant and that interfacing includes consistency with the software and everything else. So, it would be very difficult to have a different provider take care of that. And the pricing was obtained in a competitive bid because the Federal contract has a competitive bid.

So from the timing perspective, from a consistency perspective, we recommended that the Federal GSA, that's in that Resolution, that is in the packet.

MR. HANLEY: If I may, the fact that they did go through the GSA process, which is also recognized in New Jersey Local Public Contracts Law as an exception, that's how we can avoid having to go through a separate competitive bid.

Page 4

It's analogous to operating under a State contract. That's what this Resolution contemplates. That's how you get the authority to do it. I'm told it will expedite the process very, very substantially.

COMMISSIONER KOLODZIEJ: Commissioner
Vannoy will remember how long we labored with this
process, and on board with the new Prosecutor that
has made all of this possible. There's
considerable cost saving with these kind of
numbers and just to be able to, you know, do a
shared service kind of with the County, in my
opinion, is a step in the right direction.

COMMISSIONER VANNOY: Yeah. I think based on what they told us, we don't even need all those different fibers. It's a simple process and, you know.

COMMISSIONER BAZIAN: Question. Jim, if we didn't have a time issue, would you do it the same way? Would this still be your recommendation?

MR. DUPREY: Yeah, absolutely. It's the consistency aspect.

PRESIDENT SANCHEZ: Okay. Any other questions?

That's it for you?

MR. BELLA: Yes.

PRESIDENT SANCHEZ: Do you have a report on the plant's overtime?

PRESIDENT SANCHEZ: We used to do that. Why don't we do that again?

COMMISSIONER BAZIAN: Can we?

MR. WEISS: The reason why we stopped was because we switched payroll systems. It was a bit of a challenge getting the information out.

COMMISSIONER BAZIAN: Can we get it on a monthly basis January, February, and March? I don't want the numbers skewed by the floods in March. March will skew the numbers. We want to review this and have an idea that we want January, February, March, and April each month separately so at least we can have an idea. If there's a blip in March, that would make sense. Otherwise, if I'm just looking at numbers now with March built in it, it's going to skew the whole analysis.

MR. WEISS: I'll get you a copy of what we

had last year and we'll get it updated for this year.

COMMISSIONER BAZIAN: Yeah, I just need this year. I don't think I need last year.

COMMISSIONER RODRIGUEZ: This year would be good.

But, Commissioner Bazian, what we did was we did comparisons. We did quarterly comparisons from the year before and that helped us a lot to get on track with that because at one point that was really out of control.

COMMISSIONER RODRIGUEZ: An increase is coming. That's made public.

PRESIDENT SANCHEZ: I don't know that.

I'm asking the question whether that's something
we think or it's certain?

MR. GALLAGHER: It's certain.

COMMISSIONER LEVINE: We just don't know how much.

COMMISSIONER RODRIGUEZ: We're not talking specifically about anything.

Commissioner, if I may. This has been in print for awhile regarding health benefits. The

increase will be anywhere between 20, 25 percent.

PRESIDENT SANCHEZ: In the health plan.

COMMISSIONER RODRIGUEZ: In the State health benefits plan.

MR. GALLAGHER: If I could add one thing. They're also talking about an increase and significant reduction in the benefit side. So

you're also going to be paying more but getting
less services.

PRESIDENT SANCHEZ: The thing is, I understand that. I'm not trying to doubt or judge what you're saying. My question is dealing with the State, if the State would have done everything they promised, we would be in heaven. So, you know, I don't pay attention to what the State -- so, but I want to make a decision based on information, not on speculation.

COMMISSIONER BAZIAN: In other words, if I may just to put a bottom line. If we need the risk manager, all we're doing right now is --

COMMISSIONER RODRIGUEZ: Getting an overview.

COMMISSIONER BAZIAN: I hear that.

COMMISSIONER RODRIGUEZ: One of the things

I want to recommend from here on in, when these

conversations are being had, I'd like our counsel to be here. If we want him to investigate after the fact --

PRESIDENT SANCHEZ: Especially in kind of -- when we need a legal opinion not based on speculation, but a legal opinion the counsel should be involved, because everything we're saying and do we should be on record when we make a decision.

MR. GALLAGHER: That's fine. I can advise George and work around George.
