MR. AMODIO: On the roll.

(Roll call was taken, all Commissioners

present respond in the affirmative. Commissioner

Sanchez was out of the room and Commissioner

Levine not present yet)

MR. AMODIO: Thank you.

You have a quorum.

The time is 9:41 a.m.

All of the requirements of the Open Public Meetings Act have been met. Commission meeting notice have been furnished to all Commissioners, City Clerks of Paterson, Passaic, and Clifton, North Jersey Herald News, The Record - Passaic County edition and the Commission's Executive Staff with a copy posted on the main bulletin board of the Clifton facility.

If everyone will please rise.

Commissioner DeVita, would you please lead us in the Pledge of Allegiance.

Commissioner Sanchez is here.

We have a couple of attorneys here. We're going to go into closed session.

COMMISSIONER BAZIAN: Move it.

COMMISSIONER KOLODZIEJ: Second.

MR. AMODIO: Motion by Commissioner

Second by Commissioner Kolodziej.

WHEREAS, the Open Public Meetings Act permits the exclusion of the public from meeting in certain circumstances; and

WHEREAS, the public body is of the opinion that such circumstances presently exist;

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of Passaic Valley Water Commission:

- 1. The public shall be excluded from discussion of the hereinafter specified subject matters; the general nature of the subject matters being: Financial, Insurance, Personnel,
 Contracts, Negotiation, Security; under Law,
 Summary/Aging, North Arlington v. PVWC, Lodi v.
 PVWC, Delford Gardens, Filters, Bohne v. PVWC,
 Prospect Park Standpipe. Under Personnel, we have
 Summer Hires, Point View Reservoir, New Hires,
 Increments. Under Administration, we have
 Lyndhurst Agreement, Shut-Off Bad Check Policy,
 DEP Allocation, Professional Services, and any
 other matter as may be discussed in camera.
- 2. It is anticipated at this time that the above-stated subject matters will be ratified during public meeting following or as soon thereafter as the reason for the discussion no

longer exists.

3. This Resolution shall take effect immediately.

Second by Commissioner Kolodziej.
On the roll.

(Whereupon, Commissioner Levine is present at 9:40 a.m.)

(Roll call was taken, all Commissioners respond in the affirmative.)

MR. AMODIO: Roll call.

(Roll call was taken, all Commissioners respond in the affirmative)

MR. AMODIO: You have a quorum.

The time is 11:35 a.m.

We'll go back to the start and we have the committee reports.

Any further reports from any committees?

COMMISSIONER LEVINE: I don't want to get

into everything --

COMMISSIONER SANCHEZ: I have to be excused. I have to be somewhere in a half hour.

COMMISSIONER LEVINE: I don't want to bring this up. I didn't want to bring this up because it's going to be in discussion.

I want to get that Amnesty Program going and me and Commissioner Bazian have a little bit of a discrepancy on how to word this. So I wanted the Board to actually give us a direction which way to go.

I know Commissioner Kolodziej was more on board with what I was saying; so was the staff,
Yitz and them, but we want to hear it from you.

They came up with, I guess, it's a late, a fee that they're going to give. We talked about 30 percent of the fee to the person who turns the person in for theft of services. It could be anywhere from 150 to a couple of thousand dollars. The answer on that was to give 30 percent of that fee or just give a flat rate. One fifty is a little low. Nobody is going to turn anybody in. Maybe 250 or 500, give a percentage of the theft fee that they're going to collect and the theft fee changes depending on how big the main is, you

know, that goes to the house.

If it's five-eighths main, the theft fee may be only \$548. If it's a two-inch main, it goes up to like 3,000.

COMMISSIONER DeVITA: We haven't started this yet?

COMMISSIONER LEVINE: No, no.

COMMISSIONER KOLODZIEJ: We want a consensus from the Board.

COMMISSIONER LEVINE: I want to start, the problem is -- be quiet. The problem is, you know, we want to know about the employees because the employees are going to find people, turn people in, know people.

Myself and Commissioner Kolodziej as well as the employees feel, I feel our employees should be offered the same as everybody on the outside, whether it's a person who cuts the lawn or the person who works in Customer Service and looks for this, you know, just because they're going to give more incentive to actually look for people and turn other employees in because they're going to make money because people know this is going on in our place.

COMMISSIONER RODRIGUEZ: No, it's not.

No, it's not.

COMMISSIONER LEVINE: You don't know for sure. None of us know.

COMMISSIONER RODRIGUEZ: You know what, you just said "people."

COMMISSIONER LEVINE: If this is going on, let me rephrase it. If this is going on, if other people know. So if it's not going on like Commissioner Rodriguez says, then great. Then no one is going to get the bonus, but if it is going on, I'd like an incentive to actually get them to actually tell.

You know, we looked into --

COMMISSIONER RODRIGUEZ: You want whistle blowers?

COMMISSIONER LEVINE: The union felt it would be no problem if we offered to every employee rather than offering it to just one employee, the one who looks into it.

Commissioner Bazian's suggestion was that's what they get paid to do. They shouldn't get any incentive.

Then they're not really going to look as hard I feel. If we're going to issue it to the outside people, then we should issue it to

everybody, because the theft of service --

COMMISSIONER DeVITA: So this really isn't an amnesty. It's like a bounty.

 $$\operatorname{MR.}$$ HANLEY: Whistle blower is a nice term.

COMMISSIONER RODRIGUEZ: It is.

COMMISSIONER LEVINE: This is a whistle blower program, but the amnesty program we're also working on.

COMMISSIONER DeVITA: I don't like that.

COMMISSIONER RODRIGUEZ: I said it was a whistle blower.

COMMISSIONER KOLODZIEJ: If you find somebody that is guilty of this --

COMMISSIONER LEVINE: Like the Sheriff's program, you know someone is committing a crime -COMMISSIONER KOLODZIEJ: Right.

COMMISSIONER DeVITA: So if somebody is stealing water and they come to us and tell us somebody is stealing water, do we take money off their bill?

COMMISSIONER LEVINE: No, no. That's why the word amnesty is not the right word. Amnesty is after the second --

COMMISSIONER KOLODZIEJ: No, kind of like

the State when they did the income tax several years ago. They said, look, we know, if you come forward --

COMMISSIONER LEVINE: The word amnesty is if the person comes forward --

COMMISSIONER KOLODZIEJ: One time --

COMMISSIONER DeVITA: What's amnesty?

COMMISSIONER LEVINE: We're still

discussing if the person comes forward.

 $\label{eq:commissioner} \mbox{COMMISSIONER KOLODZIEJ:} \ \ \mbox{How to handle}$ them.

COMMISSIONER LEVINE: We didn't get that far yet. We want to discuss first how we're going to handle the people who actually turn in somebody. That was the first part.

The second part of the amnesty program is how we're going to handle the people who actually turn themselves in, what kind of break we give them, if any, maybe just going to jail. I don't know.

COMMISSIONER DeVITA: This is people stealing our water?

COMMISSIONER LEVINE: Yeah.

COMMISSIONER KOLODZIEJ: Exactly.

COMMISSIONER RODRIGUEZ: Like the case in

Passaic.

COMMISSIONER KOLODZIEJ: Let's make sure that everybody gets that form that you gave us so for the next meeting they'll have that.

MR. WEISS: Yes.

COMMISSIONER LEVINE: Our main thing is give 30 percent of the theft, make a set number and also do we offer this to our employees?

That's where we need direction.

COMMISSIONER KOLODZIEJ: And if it's a bad idea, tell us so we don't spin our wheels.

PRESIDENT VANNOY: Let me -- Jim has -- MR. GALLAGHER: I need to weigh in on this.

Giving it to the employees would be a term and condition of employment. It will have to be negotiated with the union.

COMMISSIONER KOLODZIEJ: Okay. So that's an answer. Okay. Take them out of the equation right now.

MR. BELLA: Overall, I think it's a good idea.

COMMISSIONER LEVINE: You think we should do the employees? Should Jim ask the union?

COMMISSIONER KOLODZIEJ: The consensus we

need is from the rest of the colleagues, if they don't think it's a good idea --

 $\label{thm:commissioner} \mbox{COMMISSIONER RODRIGUEZ: I think that's} \\ \mbox{what they get paid for.}$

COMMISSIONER KOLODZIEJ: So that's two. You need two more.

PRESIDENT VANNOY: Not do it.

COMMISSIONER DeVITA: I don't know what you're going to offer.

COMMISSIONER LEVINE: Exactly what we offer outside, 30 percent of theft services. If they get caught stealing, there's a theft fee --

COMMISSIONER DeVITA: But what's the theft fee?

MR. WEISS: It's going to be calculated.

It's going to be ten times whatever the normal either quarterly or monthly charge would be. So if a normal charge for a meter for argument's sake would be \$53 for a quarter, theft would be \$530.

COMMISSIONER DeVITA: So if somebody has a six-inch meter, according to this, the theft charge quarterly would be \$26,000.

MR. WEISS: Correct.

COMMISSIONER DeVITA: Monthly, almost 9,000. So you're going to give somebody

30 percent of that?

COMMISSIONER LEVINE: They made this up.

COMMISSIONER BAZIAN: That's one

suggestion.

COMMISSIONER DeVITA: Is that when we

collect it?

MR. WEISS: Yes.

COMMISSIONER DeVITA: So the theft charge

has nothing to do with water consumption?

MR. WEISS: No, correct.

COMMISSIONER DeVITA: The theft charge is separate and apart from the water?

PRESIDENT VANNOY: It's just a fine.

MR. WEISS: You can't call it a fine, then it becomes a legal issue. We discussed it with George years ago.

MR. HANLEY: I don't remember.

 $\label{eq:commissioner} \mbox{COMMISSIONER RODRIGUEZ:} \quad \mbox{I knew you were} \\ \mbox{going to say that.}$

MR. WEISS: Actually, George --

COMMISSIONER DeVITA: I don't know if this

is legal. If you're saying that something --

MR. HANLEY: There have been discussions.

COMMISSIONER DeVITA: If there's a

one-inch meter, you're going to charge almost

\$1,350 as a theft charge. I think before we make a decision, I think we got to see if can do it. I got serious doubts over whether we could do this.

COMMISSIONER KOLODZIEJ: All right. We got our direction. Send it to legal and legal will sit down with our committee.

MR. HANLEY: Can I say something? Again, the details, I have seen earlier written, but nothing's ever been resolved.

COMMISSIONER KOLODZIEJ: And that was the committee's point, that we can't keep talking about these issues. So right now, Mr. Chairman, you're going to get direction from Mr. Hanley.

MR. HANLEY: What I'm saying is I can't give you direction unless you give me --

PRESIDENT VANNOY: Exactly.

MR. HANLEY: Unless you give me precise, laid out details.

COMMISSIONER DeVITA: Isn't the question to be researched and decided, if we find somebody is stealing water from us, however we want to define that, are we able to impose an additional charge, a penalty on them, for stealing our water?

COMMISSIONER LEVINE: That wasn't my idea. This was, you know, Yitz came up with this. My

idea was give them like a \$500 flat fee, a finder's fee or whatever you want --

MR. HANLEY: You're all over the place.

Give me something in writing concrete and specific and we'll deal with it.

PRESIDENT VANNOY: We need something in writing for George to look at to find out.

COMMISSIONER LEVINE: I want to know which way the Board wants to go, going with theft services or straight money? I'm not going to sit here and spin my wheels and go every other way. I want to know which way --

PRESIDENT VANNOY: No, the first thing is we have to find out if we can even do it.

COMMISSIONER LEVINE: First, we find out which way would the Board rather do it, then we'll figure out a flat fee or --

COMMISSIONER DeVITA: Is it possible to research the question of whether or not this organization can impose additional penalties on customers?

MR. HANLEY: That specific --

COMMISSIONER DeVITA: How's that?

COMMISSIONER KOLODZIEJ: It's in the form of a motion.

PRESIDENT VANNOY: It doesn't make sense which way we want to do it, if we can't do it.

COMMISSIONER BAZIAN: May I make one amendment?

I believe the question is can we impose a charge, penalty, fee, whatever you want to call it, and under what circumstances. I think that's --

PRESIDENT VANNOY: What was the last thing?

COMMISSIONER BAZIAN: Under what circumstances.

PRESIDENT VANNOY: Okay.

COMMISSIONER BAZIAN: You know, if we define the circumstances clearly under which we might assess the charge, what do those circumstances need to be.

COMMISSIONER DeVITA: Let's go one step further. Can we give a reward?

PRESIDENT VANNOY: Right, exactly.

COMMISSIONER BAZIAN: That would be the next question. If we can charge, if we can assess a charge, then can we give a portion of that charge as a reward to people to turn people in.

Certainly, the IRS does it and the tax --

COMMISSIONER LEVINE: They give a flat fee, a technical portion of the person's back tax is what they get.

PRESIDENT VANNOY: Okay. Next.

MR. AMODIO: IT. Anything from IT?

COMMISSIONER BAZIAN: No.

MR. AMODIO: Security.

COMMISSIONER KOLODZIEJ: No.

MR. AMODIO: Legal affairs.

COMMISSIONER BAZIAN: No.

MR. AMODIO: We'll go onto the Executive Director's report.

MR. BELLA: Today we're finishing up the Main Avenue/Clifton Avenue operations. We're turning the valves on and there may be some dirty water today, and that's probably three more phases to this.

I'd like to compliment the Engineering Department and the Distribution Transmission Department.

The Engineering Department, under Jim's direction, Pat Porcaro has done a great job on a very complicated issue.

The Distribution Department working the valves and getting everything lined up,

coordinating everything under Kevin Byrne's direction has done a fantastic job.

It's a very complicated operation and it's the key. You know, this is the kind of issues that we're going to be faced with over the next 15 or 20 years, probably even longer.

COMMISSIONER DeVITA: And I want to thank

Andy Bisesi for coming out and taking all the sand

and grit out. I didn't have water all day.

MR. BELLA: They worked real hard.

COMMISSIONER DeVITA: They came out real fast.

COMMISSIONER RODRIGUEZ: Andy, he does a great job. He really does.

MR. AMODIO: Any further questions?

Next we have request permission to advertise Contract #12-B-11 "Furnish and Deliver Valve Service Truck and Appurtenances."

Ouestions?

No questions.

COMMISSIONER KOLODZIEJ: So move.

MR. WEISS: Cash on hand is \$14.8 million.

Our accounts receivable are at 11.7

millions. Our 30 days or less receivable are 11.1

million, which is approximately 95 percent.

Accounts payable is 4.2 million.

Our audit is coming along nicely. We are mostly done.

COMMISSIONER BAZIAN: If I may?

PRESIDENT VANNOY: Yes, you may.

COMMISSIONER BAZIAN: Having been an auditor myself, going through an audit is one of the most difficult things for anybody. All the things I'm hearing with regard to the audit have

been positive and I think Yitz and the accounting department is doing a good job.

COMMISSIONER DeVITA: I'm sorry, where were we? How much more do we have?

MR. WEISS: They tell me they're mostly done. The auditors are actually coming here tomorrow morning to review a draft of a draft; so.

COMMISSIONER DeVITA: Do we have due dates for our audits?

MR. WEISS: I believe it's the end of May.

COMMISSIONER DeVITA: I got a question.

Joe, you said before you wanted that report. Is that going to screw up our audit?

MR. BELLA: I don't think so.

MR. HANLEY: That's for last year.

COMMISSIONER DeVITA: No, I understand. I mean, as far as Yitz is spending time with the auditors. I don't know.

COMMISSIONER BAZIAN: By the way, audit does take into account if they know significant, for example, Lodi is something that -- is Lodi going to show up on the financial?

MR. WEISS: Absolutely.

COMMISSIONER BAZIAN: That's material, I would have expected that.

MR. AMODIO: Okay. Anything further?
