1 PRESIDENT SANCHEZ: Good morning, Guys. MR. AMODIO: We'll do roll call, but for 2 3 the record, due to religious observances, Commissioner Bazian and Controller Weiss will not 5 be here today. On the roll. 6 7 8 (Roll call was taken, all Commissioners 9 present respond in the affirmative. Commissioner Vannoy is not present yet. Commissioner Bazian is 10 11 absent) 12 MR. AMODIO: You have a quorum. 13 14 The time is 9:00 a.m. 15 All of the requirements of the Open Public 16 Meetings Act have been met. Notices have been 17 furnished to all Commissioners; City Clerks of 18 Paterson, Passaic, and Clifton; North Jersey 19 Herald News; The Record - Passaic County edition and the Commission's Executive Staff with a copy 20 21 posted at the main bulletin board at the Clifton 22 facility. 23 Will you please rise. 24 Commissioner Cleaves, would you please 2.5 lead us.

1	PRESIDENT SANCHEZ: All right. Anybody?
2	Joe? Alan? Who wants to start? Jim?
3	MR. GALLAGHER: I wanted to say that on
4	Monday, the supervisors union did vote to ratify
5	the contract as was originally presented.
6	And I don't know, I'll leave this to
7	George or Alan, I'd like to talk a little bit
8	about the rank and file, if we can, just to talk
9	about strategy. And I'd like to talk about that
10	in closed session, if I can, because that has not
11	been ratified.
12	They agreed to all the terms, which is
13	very good for Passaic Valley Water and I believe
14	it's a very fair offer on the table. I also
15	believe it's fair for the rank and file.
16	MR. AMODIO: So if someone would please
17	make a motion.
18	COMMISSIONER KOLODZIEJ: So moved to
19	approve.
20	MR. AMODIO: No, I'm talking about to go
21	into closed.
22	COMMISSIONER KOLODZIEJ: Okay.
23	PRESIDENT SANCHEZ: What would you like to
24	do first?
25	MR. GENITEMPO: We can go into closed and

talk about both and come back. 1 2 MR. AMODIO: Commissioner Kolodziej offers the following Resolution for adoption: 3 WHEREAS, Section 8 of the Open Public 5 Meetings Act permits the exclusion of the public 6 from meeting in certain circumstances; and 7 WHEREAS, the public body is of the opinion that such circumstances presently exist; 8 9 NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Passaic Valley Water Commission: 10 1. The public shall be excluded from 11 12 discussion of the hereinafter specified subject 13 matters; the general nature of the subject matter 14 being: Financial, Insurance, Personnel, 15 Contracts, Negotiations, Security, Law. Under 16 Personnel we have Union Negotiations: Supervisors 17 and rank and file, and any other matter as may be 18 discussed in camera. 2. It is anticipated at this time that 19 20 the above-stated subject matters will be ratified 21 during public meeting following --22 MR. HANLEY: Portions, portions. 23 MR. AMODIO: What? 24 MR. HANLEY: Portions of the above-subject 25 matter.

1	MR. AMODIO: Okay. Thank you.
2	During public meeting following or as soon
3	thereafter as the reason for the discussion no
4	longer exists.
5	3. This Resolution shall take effect
6	immediately.
7	Second by Commissioner DeVita.

12	Vannoy is not present yet. Commissioner Bazian is

ratification of the contract with the supervisors 1 2 union and also the non-aligned. COMMISSIONER DeVITA: Offer them the same 3 increments. Is that all we have to say? Can we do one? 5 6 COMMISSIONER KOLODZIEJ: Yes. It's the 7 same thing; offering the same thing. PRESIDENT SANCHEZ: Do I have a motion? 8 9 COMMISSIONER DeVITA: So moved. MR. AMODIO: Moved by Commissioner DeVita. 10 11 Do I have a second? 12 COMMISSIONER KOLODZIEJ: Second. 13 MR. AMODIO: Second by Commissioner 14 Kolodziej. 15 On the roll. 16 MR. HANLEY: Excuse me. 17 MR. GENITEMPO: Just for the record, the 18 Resolution for the Commission to ratify the 19 Memorandum of Agreement agreed to by the 20 supervisors by their vote on Monday, 21 September 23rd, 2013, accepting the terms of the 22 Memorandum of Agreement between the union and the 23 supervisors union and the Commission. And also to 24 provide for the same benefits and increases to the 2.5 non-aligned employees in the same terms and

1	conditions as that of the supervisors' Memorandum
2	of Agreement. And I believe that's the proper
3	terminology.
4	MR. AMODIO: Thank you.
5	PRESIDENT SANCHEZ: So do I get a motion.
6	MR. AMODIO: I have a motion and second.
7	We're on the roll.
