PRESIDENT DeVITA: Call the meeting to order, please.

MR. AMODIO: On the roll.

If everyone will please rise. Commissioner Kolodziej.

MR. GOLDBERG: Dan Goldberg.

MR. AMODIO: Do you wish to be heard? No?

Anybody in the hallway? No?

We'll start with committee reports.

PRESIDENT DeVITA: Personnel, finance;

whoever wants to go first.

COMMISSIONER LEVINE: I'll go first.

We really didn't go over much. Last minute our Executive Director had to go meet with the EPA so almost everything we had to go over was with the Executive Director. The only thing we went over is the payrolls and some of the final Page 2

overtime figures, but we didn't even have -- we're looking for different reports from Yitz, which we didn't have. So the meeting was kind of short this month due to our Executive Director being absent.

PRESIDENT DeVITA: Does anybody else have a report?

Yitz.

MR. WEISS: Before the next meeting for sure.

PRESIDENT DEVITA: That's overtime?

COMMISSIONER LEVINE: Different overtime.

We want comparisons from last April to this April.

We want three months comparison. We want that

report so we can actually see if we're saving and actually if each department head is doing their job in reducing their overtime.

And we also want to know how many main breaks from this year to last year, quarters, to put that in perspective, too.

PRESIDENT DeVITA: To prepare the number in ratio. So for the next meeting in August, we'll have that, right?

COMMISSIONER LEVINE: We hope so.

MR. WEISS: Yes.

COMMISSIONER LEVINE: We want to go over a lot of the overtime, but we had no personnel there.

COMMISSIONER KOLODZIEJ: Didn't we say we Page 3

were going to reschedule the people who came to us because we feel that they promised us certain things when they met with us so we want them to know we mean business?

COMMISSIONER LEVINE: Right. We met with Mike Ciollino, I believe his name was, to make sure. We want to bring them back. It should fall in the Executive Director's to actually make sure it gets implemented. It might go in one ear and out the other. We might bring them back and

actually go over the numbers with them so they know, to see if there is progress.

PRESIDENT DeVITA: Good. Very good. Personnel.

COMMISSIONER VANNOY: We've had about, I guess about four meetings on our Table of Organization. So, I think that we're close. Obviously, we're going to give you guys something to look at today and hopefully, we can, you know, move forward and get this done. We spent a lot of time but, you know, obviously still there's only three of us and another four of you guys have to agree. Again, we made a lot of progress. We'll give it to you today and see how we can work it out.

PRESIDENT DeVITA: I think what we talked about, if I may, Bobby, trying to have everybody get it today, receive it today, hold questions, whatever, and maybe schedule a special meeting.

COMMISSIONER VANNOY: We're just going to Page 4

give it out today. Let you guys take a look at it. No questions because obviously we'll be here forever.

PRESIDENT DeVITA: It will be done in closed session.

COMMISSIONER VANNOY: Right. Exactly. We'll schedule a special meeting to go over that and we can bring back all our questions and concerns.

COMMISSIONER KOLODZIEJ: Mr. President, I'm assuming if there are any questions, we can call any one of the committee members and ask our questions so we're prepared with an answer by the time we get here?

COMMISSIONER VANNOY: Yeah. I don't think it's a one step process. Even when we come back with our special meeting --

COMMISSIONER KOLODZIEJ: But I'd rather have an answer to my question rather than have everybody listen to me. So I just want to know if I can call anyone?

COMMISSIONER VANNOY: Yes, you can.

PRESIDENT DeVITA: Do we want to schedule a meeting now so we have it?

COMMISSIONER VANNOY: I think we should.

PRESIDENT DeVITA: Our meeting in August is the 17th. We want to do it before?

COMMISSIONER VANNOY: I'm on vacation prior to that.

PRESIDENT DeVITA: What is it?

COMMISSIONER KOLODZIEJ: The week of the 22nd we're looking at.

PRESIDENT DeVITA: What's the last week?

want to is, well, if you convene and adjourn it will be violating the Open Public Meetings Act until such time as the 9:00 a.m. is completed. Follow me?

PRESIDENT DeVITA: No, I didn't.

COMMISSIONER RODRIGUEZ: Yes, I did.

MR. HANLEY: Instead of rescheduling the insurance fund.

PRESIDENT DeVITA: We're going to have our special meeting for Table of Organization August 18th at 9:00, correct? Everybody's good for that? No vacations?

You'll let Commissioner Sanchez know. And you'll all get proposals, copies of old and new today to look at. I'm sure everyone will have a lot of questions. We spent a lot of time on this.

COMMISSIONER VANNOY: That's at 9:00.

PRESIDENT DeVITA: August 18th, 9:00. Okay.

IT/security.

COMMISSIONER BAZIAN: Yes. On IT, we are

focusing on, right now, some of the emergent issues that we have to deal with in the technology aging work stations that are failing and costing us extra time with our vendors. The vendors are reviewing all of the work stations and will be presented to us a list of the work stations that

he recommends that be replaced in a short period.

The other thing is that we had an issue with our SCADA system. I found out immediately subsequent to the meeting that our SCADA system had not had an effective backup for months. In my discussion with Jim Gallagher, he became aware of it. Basically, it was along the lines of whatever it takes, let's get a backup and we had a backup that day.

So we're now getting backups on the SCADA system and they're looking at replacing the SCADA system, which is the server on which the SCADA system is running is I think like seven or eight years old, which in computers term is very, very old. So, obviously, I'm very concerned about it. So they're looking into replacing that server.

PRESIDENT DeVITA: Question. The vendor we're going to buy from is going to tell us what we need to replace?

COMMISSIONER BAZIAN: No. The vendor is going to recommend what needs to be replaced. What we purchase, we purchase directly from the manufacturer from Dell.

One of the things that we've been very careful with in the IT committee is not to allow or present ourselves with a situation where the vendor will be self-feeding themselves business. Okay. And it's kind of a fine line you walk when a vendor comes to you and says, "Hey, this machine is a problem. We need to replace it." If there's Page 8

an additional cost and time or whatever, you have to evaluate that how real is that as opposed to somebody trying to make a couple of extra bucks.

One thing I can tell you is my understanding of the technological situation here when we're talking about servers that are very old, operating systems that Microsoft no longer even supports. You can't buy technical support on Windows 2000 anymore, it kind of makes the argument for itself.

The fact of the matter is, we are spending money on these old machines, when a power supply dies, when a hard disk dies, we're spending money but the money we're spending right now is of low

cost. If we replace the machines, which by the way is included in the contract that we signed with the vendor, so not only are we not paying for the replacement because it's included in the contract, we're also, hopefully, going to be minimizing time going forward because we'll be dealing with new technology.

COMMISSIONER KOLODZIEJ: I think as was crucial to me was we had budgeted for a lot of this and if we keep being aggressive, we should have a lot of this up and running by the end of the year. And then for next year, because we can phase this, we can budget again for next year.

So we're in good shape financially to move and chairman is very knowledgeable so he keeps

Jeff and I really moving.

COMMISSIONER BAZIAN: One last issue.

We're looking at, you know, we're looking at replacing our telephone system. Our telephone system is already, for the most part, out of support. We're getting some support, as I understand it.

Jim has been reviewing telephone systems.

Jim, you can give a quick report? You're doing that directly.

MR. GALLAGHER: Commissioners, we met with three vendors over the last three weeks. All but one did an inventory security. They've been walking the properties. The advantages that all three will do the wiring as part of the State contract price. It will all be voiceover. So instead of having a bundle wires, it will be down to a single wire. It's state of the art and it appears that it will also help us tremendously with our computer changeover.

So, actually, we'll be saving money in the long run. There won't be two companies pulling wire through the system and we hope to have a report with a recommendation as early as, you know, some time in August.

PRESIDENT DeVITA: Security.

COMMISSIONER KOLODZIEJ: I checked with Mr. Bella. The Sheriff has not visited. He promised us in two weeks. Commissioner Vannoy and I are not going to be tolerant in not meeting the Page 10

deadline. So I will call him. He's away now. I will call him.

COMMISSIONER VANNOY: We met with him -PRESIDENT DEVITA: We met with him two
years ago.

COMMISSIONER KOLODZIEJ: No, that was the other Sheriff.

COMMISSIONER VANNOY: Yeah, the other Sheriff. He's up in Wayne.

COMMISSIONER VANNOY: He said in two weeks.

COMMISSIONER KOLODZIEJ: I will hold his feet to the fire.

The other thing we need to do is see how we're doing with the dark fiber with the County Prosecutor's Office with the security.

COMMISSIONER RODRIGUEZ: We're waiting for a proposal from him?

COMMISSIONER KOLODZIEJ: Yes. And he told me he would have it in two months. It was based on his visit here and he wanted to do a walk through.

PRESIDENT DeVITA: Two weeks.

COMMISSIONER KOLODZIEJ: Two weeks for the walk through and two months for the proposal.

COMMISSIONER RODRIGUEZ: He hasn't done the proposal?

interesting to read the publicity. He's trying to do some of the plans and that was one of the things he put forward as to how he would minimize the expense for the Sheriff's Office. He intends to use retired officers at a much reduced rate. We wouldn't have to pay benefits. It would be interesting to see the proposal coming forward. But we're going to hold his feet to the fire. We waited two and a half years.

COMMISSIONER VANNOY: We heard a lot of good suggestions but until he does something, it doesn't mean nothing.

COMMISSIONER KOLODZIEJ: He gave us a time.

PRESIDENT DeVITA: Anything else on any committee reports?

Any questions?

Joe?

MR. BELLA: As you know, we had a really burning hot streak there, dry; our demands were up substantially. As a result of that, we always end up with some type of main break.

We did have a 24-inch in Paterson. Our guys did a great job. As it turns out, it was only a 12-inch. Our people did a great job

getting that squared away, isolated, and fixed in a very short amount of time concerning the main Page 12

break.

I haven't personally checked on the paving and everything, but I want to go down there myself before I say anything good about that because I want to make sure that's put back to the town's specifications. There was a lot damaged to that road.

At the plant, filters are progressing. The work on the filters is progressing very nicely. We have two of the big filters back in service, which really gives a lot more breathing room. They'll be moving to the smaller fits so it's not as critical.

The other thing, last week, as you know, we had an outage, the ozone generators; heat. All the sophisticated gears are really nice, but they all depend on air conditioners. And the air conditioners, believe it or not, to keep the motor control centers, actually, because they're up on that roof and very hot, they must have caused a failure or we had some kind of an electrical surge that knocked out that type of compressors.

So we were able to get that fixed, back up

and running within the day. Plant staff did a great job attending to it. And that was cleaned up.

The other thing is one of our Morris

County pumps that were out. Tomorrow we're

actually going to take it out send it to shop and

So those are the three big issues I wanted to talk to you about.

The other thing is I have for you just a brief report on the capital work we're going to be doing over the next couple of years so you know what projects are coming up. I'll just pass them out. And just summarizes what we're immediately focused on.

A lot of these projects are projects that have to do with cleaning the lining, reoccurring capital costs, separated from street projects and capital; reoccurring projects, like cleaning the

lining, valve replacements, hydrant replacement where we're out there doing that year after year after year trying to get ourselves positioned in a way that we're really starting to rehab our distribution system.

That's important because it saves, by cleaning the lining, it saves lots and lots of money on two issues. One is repairs. As you clean the lining system, the first year you have a little bit increase in main breaks at that time after you do it. Then what happens is, now you Page 14

П

П

replaced all the valves, everything is wide open, when you have shocks in the system, they tend to dissipate and not blowout the mains.

So generally you see the first year, incidents of main breaks go up and after that drops down below what your average is for that particular set of mains.

Opening up hydrants or putting new hydrants, the obvious benefit of that is the reliability of the system.

And the other thing is we're doing some main replacement, which is sort of things we haven't done. We're trying to hit the mains that break the most. For instance, we're doing one on

Notch Road now. It's a cement pipe which fails at least once a year, which is for a mile or two main. We should see a main break once every ten years on that. So we're replacing that with a ductile. We're going to be continuing with that.

Our project over on Clifton Ave., our 30-inch main is progressing nicely. Our people are doing a lot of work inhouse. Some of the specialty work we figured out how to avoid some of it, such as using valve insertions.

And then we're starting our planning right now for our 24-inch main in Paterson. We're going to start planning that. That's going to be our next big project, the rehab of that 24-inch main. This is the one I thought failed. This is the

pvwc726.txt one, the 12-inch main we had a failure on. comes off, it runs down Van Houten and all the way out. So we got to rehab all the valves.

COMMISSIONER RODRIGUEZ: To the Falls area?

MR. BELLA: All the way up Van Houten. It goes pretty far up there. So next year we're going to be working on that. We're going to try to schedule that so it has a minimal impact. That's a real high traffic area. It has to be

done.

COMMISSIONER KOLODZIEJ: I have a question. How do we notify the people in the area that's going to be affected? I know we can post it on our web site for people that are savvy there. But sometimes when you're doing this, if it passes a residential zone, people are calling me saying, "I have dirty water, why, why, why." So is there any way, I don't expect an answer today, but if can be sensitive to the fact that these projects are ongoing for months at a time, if there's a better way. The easy way is to post it on the web site.

MR. BELLA: And the newspapers.

COMMISSIONER KOLODZIEJ: There you go.

COMMISSIONER RODRIGUEZ: You could use the public access channel.

COMMISSIONER KOLODZIEJ: Something, something, exactly.

> MR. BELLA: Do like a little presentation. Page 16

COMMISSIONER KOLODZIEJ: Exactly.

COMMISSIONER RODRIGUEZ: Use the public access channel.

COMMISSIONER VANNOY: Word of mouth.

COMMISSIONER RODRIGUEZ: Believe it or

PRESIDENT DeVITA: Anything else? Thank you, Joe.

COMMISSIONER KOLODZIEJ: I'm just curious, how do it work out? Since this was a change from the way we used to do things, are we satisfied? Do we need to put anything in our RFPs? Do you know?

PRESIDENT DEVITA: Get Jim.

I think there were some issues. We'll try to move on it.

COMMISSIONER KOLODZIEJ: I'm trying to see if you're going out on an RFP.

PRESIDENT DeVITA: Get Jim Gallagher in here.

MR. AMODIO: I believe Ed Farmer is here for that.

COMMISSIONER KOLODZIEJ: Do we need to put anything else in our RFP? You had a year of working with a firm and now we're going out again.

MR. GALLAGHER: I mean, the firm seems to be satisfactory.

COMMISSIONER KOLODZIEJ: Do we need to tighten anything up?

MR. GALLAGHER: The one thing we need to put into the policy is, we have not had this occur yet, but what is the criteria for excluding people from being eligible from the property. I mean, I think there's some quite obvious ones if they're on the terrorism watch list, per se.

PRESIDENT DeVITA: Can I make a suggestion? Maybe we should discuss that with Mr. Genitempo.

Next we have Ed Farmer.

MR. FARMER: All right. We're working with Joe Bella and Jim Gallagher on an application that is due on Friday to the New Jersey Department of Environmental Protection. They have a program that's a new program that is utilized through Federal dollars called the License Operator Internship Program. And the concept of this

25

program is to allow to get more people involved in the water industry that, you know, could be licensed operators in the future. They will pay up to \$35,000 per operator. As of now we're only allowed to apply to one, but they're funding 60 in the state. If they don't get 60 applications, they will allow us to increase if we would like that.

So it pays up to \$35,000 of the expenses. It will be awarded quickly, because it's September 1st, 2011 through August 30th, 2012 is when the money has to be expended.

So we'll find out -- we'll apply on Friday and we'll find out the next two to three weeks if we're successful.

MR. BELLA: Salary.

COMMISSIONER RODRIGUEZ: Oh.

MR. BELLA: First year's salary.

COMMISSIONER RODRIGUEZ: Oh, wow.

PRESIDENT DeVITA: Question. Is there any down side to this? I mean, I read this.

COMMISSIONER LEVINE: Second year we have

26

to pay for the salary ourselves?

MR. FARMER: I'm sorry, you can answer.

MR. BELLA: We have to pay for the first year salary also.

COMMISSIONER LEVINE: Would we normally hire these persons anyway even if it wasn't for the grant?

MR. BELLA: Absolutely. Because we're shorthanded.

COMMISSIONER RODRIGUEZ: We're looking to hire people now. We're shorthanded.

PRESIDENT DeVITA: No negative? We got to vote today?

MR. FARMER: No. It's up to 35,000. The Resolution is before you today and will be submitted on Friday.

PRESIDENT DEVITA: Can we have a motion?

COMMISSIONER BAZIAN: I have a quick question. \$35,000 for salary, what do we expect the salary to be?

I talked to people down at the State, we're

MR. BELLA: That's it. That's the whole point of the program, to get people in the system so we can start progressing.

COMMISSIONER RODRIGUEZ: And training. PRESIDENT DeVITA: Thirty-five thousand dollars per operator?

MR. FARMER: I'm going to apply for one now. It's Federal dollars that are going through the State DEP. If they don't get 60 applications, if we're interested in asking, you know, we've

for more.

COMMISSIONER VANNOY: If we hire them and pay more, that's on us?

MR. FARMER: It's a reimbursement. We're going to have to put in, you know, up to \$35,000 for reimbursement.

PRESIDENT DeVITA: These were people we were going to hire anyway.

MR. FARMER: Thank you very much.

PRESIDENT DeVITA: Next.

MR. WEISS: Cash on hand is 12.3 million.

Accounts receivable is at 12.6, which seems high but that's normal for this time of the year. Our 30 days or less accounts receivable is

30

at 12.1, which is 96 percent.
