MR. AMODIO: On the roll.

(Roll call was taken, all Commissioners present respond in the affirmative)

MR. AMODIO: Commissioner Sanchez is excused absence.

The time is 10:34 a.m.

You have a quorum.

All of the requirements of the Open Public Meetings Act have been met. Commission meeting notice have been furnished to all Commissioners, city clerks of Paterson, Passaic, and Clifton, North Jersey Herald News, The Record - Passaic County edition, and the Commission's Executive staff with a copy posted on the main bulletin board at the Clifton facility.

Would everyone please rise.

Commissioner Vannoy, would you please lead us in the Pledge of Allegiance.

Is there any member of the public wish to be heard?

Hearing none, moving on to the Executive

Director's report.

MR. BELLA: Okay. This week, actually as we speak, we're finishing up the repair on the large main. To that end, I brought a little show and tell kind of thing. I just wanted to show you, that's what a main break on a steel pipe looks like. This is where the two pipes originally were joined together. Probably during the process of, you know, just settling or maybe because of the rains, it split between these two pipes.

Now, there was a repair done on this before. It's interesting, you can see here from the side, there's like a bump here and there's a big flat -- this is the pipe right in here and this is the repair piece. The repair piece split, probably done 50 years ago. We don't know. And that split and what we did we had to go back there and we would put a piece and sure it up.

Apparently, one time that whole area was changed. There's a huge retaining wall there, really dangerous job. And our people did a really good job; almost no overtime, by the way because it didn't affect people. You know what I mean. We could service all of our customers without any

problem. So it wasn't like something we had to do and work overnight, you know, to get it done and get people back in service. So, they did a job job, really good job.

The main itself is from the -- before the -- right around 1900 and we don't know when the repair was done previously.

That's what it looks like. Here it is. Just split, this is the interior of the pipe.

okay.

That's the first thing.

COMMISSIONER BAZIAN: What size was that pipe?

MR. BELLA: Forty-eight inches in diameter.

MR. BELLA: It wasn't a high profile because not many people were really affected. And even during the repair, we had like one wholesale customer. I asked him to cut back a little bit.

And everything went really well; reversing the whole shut down. It's all back in service.

The other thing I wanted to talk about is, there was some -- well, this Flow Cytometer. We

want to advertise it.

Originally we had scheduled a, what they call ICP. ICP stands for Inductly Spectra Photometer, which measures heavy metals. We've since then want to split that. We were going to do that this year and this other thing next year.

We got our old ICP working and so we want to get this.

The reason why I'm telling you this is because doing this the old fashioned way with a microscope and somebody counting. Took a lot of tech time. Probably in the summertime it probably took a person a day, a week to do this. So one of the things we're trying to do is automate as much as we can in the laboratory. And this is one of the first steps. And we figured that this was the most cost effective way of sort of minimizing laboratory time, tech times.

Now, the other thing is we completed a bunch of the personnel moves that we did in the Page 4

laboratory; that we wanted to do in the laboratory. So, we're hoping, not hoping, the overtime will come down there. The new person we hired in the lab is now being trained. We moved a person from the plant operations into the plant

and we now are fully staffed in the laboratory.

Now, we have one person, who for medical reasons, will have to be moved out but we'll deal with that in a couple of months. They have to put another lab technician in there, but we'll see.

At any rate, so we should see some pretty, over the next, certainly by the end of the year, we should see a fairly big difference in the overtime with the laboratory. And we took some immediate steps. We rearranged some of the lab schedules and the operator schedules to make it a little bit better and a much more efficient way.

PRESIDENT DeVITA: Joe, can that be done at the plant? This was at the lab, right?

MR. BELLA: This was at the lab, but we also made some changes in the plant schedule and we're going to continue to do that. We're going to downsize the staff. We have four people in there, we're not going to do it just yet, like, do the upgrade on the SCADA, which is already budgeted for and everything. Once we get that done, we can start shrinking down the staff size. Instead of have four people around the clock, we'll be down to three people around the clock,

SCADA system's moved in and up and running then we'll really start to take advantage of some of the manpower.

PRESIDENT DeVITA: I just want to make a statement for our stenographer, for her benefit.

We're probably going to be posting our minutes on the web site, so the less cross-conversation and the less interruption we have the better off we are so she can accurately get what we say. All right. So I would appreciate it.

Plus, anybody from the outside who might make a presentation to us, we'd like them to stand.

So, stop interrupting and stop with our cell phones and everything else. Okay.

Thank you.

COMMISSIONER KOLODZIEJ: I just want to say, finance, our chairman is not here yet. We spent a great deal of time talking about this. We realize that when you save time it also saves money. So we really want the personnel committee to seriously look at that because we see a cost savings and time picked up from employees who have to do things manually will now be doing so. If

you can put that on the agenda.

Since you mentioned our stenographer, IT Page 6

committee, these committees are working very, very well, a lot of good stuff, a lot of dialogue. What the IT committee will be recommending today, maybe it belongs under New Business? What do you think?

It's a follow-up to our stenographer, because a lot of the things that we get in our minutes are just typos, misspellings, and whatever. So we are recommending that Louis take a look at those minutes and, you know, bring the correct spelling of the vendors, correct spelling of whoever is here, to do that. It will in no way alter the minutes, but it puts a finished product on and we would like to start, we said, right, Commissioner Bazian, with this meeting. So we need to okay that policy.

PRESIDENT DeVITA: The policy being that he would edit?

COMMISSIONER KOLODZIEJ: He would edit it only for misspelling and typos and things like that. So that when the minutes appear on our web site, that they are accurate as -- they are accurate, you know, in addition to what you've

So I would so move that we do that.

PRESIDENT DEVITA: Is there a second?

Joe and I have been having breakfast meetings every week, kind of like a coffee clutch, and discuss different things. We discussed Customer Service. We have some changes planned.

MR. BELLA: Yes.

In Customer Service, we're working on with

probably, which we had talked about it and I reported on it previously, go from about 7:30 to about 6:00, 7:00. We're not quite sure how it will work out, the exact hours. COMMISSIONER VANNOY: I think we had a conversation and it's not that we're doing any overtime, because it allows us to work Saturdays, correct, without paying --

COMMISSIONER VANNOY: As far as looking to do it, I think we can already do it. I don't think we have to look to do it.

PRESIDENT DeVITA: Well, just to rearrange the personnel. Everything will be done in effect by May 1st.

COMMISSIONER BAZIAN: Question.

Are we talking just Saturday hours? No Sunday hours?

PRESIDENT DeVITA: Correct. Right now we have no Saturdays and we have nothing past what, 4:30, 5:00. So I think that will be a big start for us.

okay.

Joe, we also discussed cameras. What's Page 11

MR. BELLA: We have the cameras installed. Training for people that would have access to it is needed. I believe the cameras at the guardhouse are actually, you know, up and running, and so that the guards can view, which is where it should be.

Other than that, the work has been completed on that, on the grant money and we've submitted all the invoices, and for that to be reimbursed by the Department of Homeland Security. Remember, that was done under the UASI grant, the security grant.

PRESIDENT DeVITA: How much was that grant?

MR. BELLA: Three hundred and eighteen dollars --

COMMISSIONER BAZIAN: Thousand dollars.

COMMISSIONER VANNOY: That's another typo.

COMMISSIONER BAZIAN: And three hundred

dollars just for the flowers, right, Joe?

PRESIDENT DeVITA: So, Joe, what's our timetable? I'm big on timetables.

MR. BELLA: The cameras are up and running now. The training for the additional people, just department heads to have use of those cameras

MR. BELLA: Department heads down at the plant and people will be trained anyway, but the cameras are up and running.

cameras one second?

PRESIDENT DeVITA: Sure. Go ahead.

COMMISSIONER KOLODZIEJ: Because both of us were at this meeting and by April we will also have a firm answer back from the Prosecutor's Office. Mr. Marotta and Mr. Bella will be trying to firm up our time into their dark fiber. The goal of the security committee and administration will be to be less dependent on the Sheriff's Officers. In fact, when we get to finance, I'll

PRESIDENT DeVITA: Commissioner Bazian.

COMMISSIONER BAZIAN: Thank you, Mr.

President.

With regards to the grant, this grant has Page 14

already been awarded, right?

MR. BELLA: That's correct.

COMMISSIONER BAZIAN: So this is money we're going to get. It's not like subject, contingent on a federal budget?

MR. BELLA: No, that money is already -PRESIDENT DeVITA: We're waiting to submit
our documentation.

MR. BELLA: We've already submitted it.

COMMISSIONER BAZIAN: When would we expect that money to come in? Any idea?

MR. DUPREY: Less than 60 days. You never know. You never really know, but we would assume it's reasonable time period.

PRESIDENT DeVITA: Okay. One more question I have, Joe.

Web site. How are we doing with our web site, the upgrading and all that?

MR. BELLA: Well, I'm not happy with the progress in getting the documents up on the web site. What we're going to do is, what we're looking into at this time is using Google documents to post our documents there and put a link to those documents. We're still in the phase of exploring how to do that. We'll have more information.

COMMISSIONER RODRIGUEZ: Is it possible, I mean, because I've just been through this in my firm. Is it possible for us to just -- I thought

we're just going to have it redesigned to make it more user friendly, to make it more user friendly, to -- I mean, there's a lot that is going to be contingent that has to go on our web site and if we have a web site that is not capable right now of that, IT committee --

PRESIDENT DEVITA: I think that's what they're looking into.

COMMISSIONER RODRIGUEZ: So my question, Commissioners, is there a possibility, we know

what we have now really doesn't work, is not user friendly. We're really progressing. There's the committee meetings. Is there a way that we can go out and find someone professional that can just look at our system and say, "This is what we can do." We just had to do that in our firm and we're not a firm like this.

PRESIDENT DeVITA: Let's hear from our IT committee.

COMMISSIONER BAZIAN: The IT committee discussed this in two phases, if I may.

Phase number one was to get the public, what I've been calling public access information, information that should be available to the public up on the web set as soon as possible.

Initially, I hoped we could have it done by this meeting. The idea to use Google docs, and I'm also embarrassed to say this, that I was upstaged by a chemical engineer --

PRESIDENT DEVITA: Mr. Bella.

COMMISSIONER BAZIAN: Chemist, sorry.

This was Joe's idea and it is, quite honestly, speaking as a technologist, dazzling in simplicity. Assuming that we can do what we want

with Googledocs. Again, I'm ashamed I didn't come up with it. It's just a great idea.

So that's phase one.

Phase two is a redesign. There are two elements that we need to deal with in a redesign. One is the visual element, okay, which, to be quite honest, our web site really needs an upgrade. Okay. There's no question about that. But the visual element actually takes a backseat, in my mind, to the functional elements.

Let me give you some ideas. Whenever we have a contract that we are advertising, we put it up on our web site on a link called Notices, that nobody would think to go to. People would think to go to the Purchasing Department. So, theoretically, in a redesigned web site that information should go to the Purchasing Department.

I could think of upgrades, perhaps, for Personnel. For example, perhaps Personnel may want to list job openings there. Maybe we could take employment applications on-line, assuming there are no legal impediments.

My point being that before we can just go Page 17

first decide what we want that web site to do.

COMMISSIONER RODRIGUEZ: If I may, I'm just going through this process myself. That would be part of the whole, you know, and I'm not telling IT, you know. That would be part of the whole scheme of things, to see what it is that we're looking for before we throw out specs to go out.

COMMISSIONER BAZIAN: And I agree. And -COMMISSIONER RODRIGUEZ: We're saying the
same thing.

COMMISSIONER BAZIAN: We're saying the same thing.

Originally, what we had thought, what the IT committee was discussing, possibly doing a business process review, because we're looking at replacing our enterprise software. And as a result of that business process review, we would get a whole bunch of information related, not only to operation software, more commonly, but erroneously called accounting software, operation software. We also could get information, theoretically, for our web site.

We took a step back at the last meeting. We had some discussions about that, about a

different approach. But, in any event, I think that perhaps, Joe, we should get feedback from our Page 18

П

department directors what they would like the web site to do for them. That will be the beginnings of a functional spec.

And, yes, I agree with you, we must go out to bid. We must get that web site redeveloped. But like I said, the initial thing, which I had hoped to have done today, which, unfortunately, didn't happen, was that we should have our schedule, you know, our meeting schedule, our setup for --

COMMISSIONER RODRIGUEZ: The basic stuffs.

COMMISSIONER BAZIAN: -- The minutes and our budget and things like that up on-line. I wanted to have that ready for this meeting. So, God willing it will be ready soon.

PRESIDENT DeVITA: That's our first step.

COMMISSIONER BAZIAN: That's our first step, yes; a redesign.

The other thing, Mr. President, my understanding and I could be wrong about this, but my understanding is that when we had this web site originally developed, it cost something along the lines 65, \$70,000. Given the advances in

technology --

MR. ADAMO: My name is Tom Adamo. I live at 4 Cliff Road, Woodland Park, New Jersey. I'm a resident of the Four Seasons at Great Notch.

A year ago, May, I submitted a letter to you people. We have a back gate on Reservoir Road which the hours of operation are from 7:00 to 7:00. And I requested that if we could extend those for two hours, maybe give us till 9:00, inasmuch as there's a lot of traffic on Route 46 after 7:00 and, et cetera.

A few months after that letter was submitted, I found out from another resident up by us, Scott Tire (Phonetic), that you people were going to give us, I believe, till 10:00 or 11:00. I originally said 9:00.

Unfortunately, we have a resident up in our community who stuck his two cents in and said he was representing a committee and sent you guys

pvwc32311.txt a letter saying they wanted 24/7, which aggravated a lot of residents in our community. We don't want the gate open 24/7. There's no need for

It's more of a convenience. A lot of our residents going shopping down in Shop-Rite or Kohl's or Willowbrook and you're coming back and it's five after seven, you got to go all the way around.

Needless to say, we had a very bad winter

and to come up Valley Road up by our complex, there's two entrances, one on Boulder which is very high by the wall. It's pretty high to come up. It's very easy to come up Reservoir Road

right off 46 in our community.

24/7.

I understand there was talk about having a traffic study. My opinion and my residents that I'm representing, we don't really need a traffic study. We're not going to have a thousand, two thousand cars passing through at 7:00 at night. It could be 25 cars, it could be 50 cars, it could be ten cars.

It's more of a convenience. And all we're asking for is maybe turn that timer up two little notches to 9:00. That's all we're asking for and it would really be helpful to us.

We do understand there's going to be a lot of construction on Route 46 I think in about another six months to a year, which is going to be a real inconvenience for us and that will be real Page 22

great help to us. That's what I'm asking you people to reconsider possibly and forget about traffic studies that other people in our community are coming to you with.

That's basically what I'm asking for, if

you could reconsider.

PRESIDENT DeVITA: Mr. Hanley, you were very much involved in this. Maybe you can --

MR. HANLEY: Yes. This is a very different proposal.

PRESIDENT DeVITA: Absolutely.

I have to recuse myself from any discussions.

(Whereupon, President DeVita recuses himself from the discussion and leaves the room.)

MR. HANLEY: I guess, you have to excuse me, I have to think like a lawyer. I guess the real -- one of the questions would be to entertain your proposal or anybody's proposal. The other gentleman represented to us that he was representing the Association and I think what I'm hearing from you is maybe not.

MR. ADAMO: That's correct.

MR. HANLEY: I think probably in order for the Board to fairly consider any proposal, we need something from whoever the official representative of the Association is, whether it's their attorney we're dealing with an authorized representative, and I don't mean that as any reflection.

MR. ADAMO: No, and I understand that.

MR. HANLEY: But we have to sort of have entity to entity, if you'll excuse the term, and knowing that we're dealing with the authorized representative and I have to protect the Board in that regard.

MR. ADAMO: I do understand that, sir.

But many of us residents, we feel that it's as if
we're going to go to a City Council meeting, get
up and voice your opinion, we're asking for some
assistance. I don't think it really has anything
to do with an attorney at our complex, a head of a
committee. These are residents who just want to
buy two hours of time, that's all.

MR. HANLEY: But you see --

MR. ADAMO: It's not a great necessity, but it's going to help us out.

MR. HANLEY: Mr. Adamo, the difference is, if you were an individual homeowner --

MR. ADAMO: Which I am.

MR. HANLEY: Well, you're in a condominium association. So that's not quite the same. You have to act through that corporate entity. You

cannot, I mean, you can act as an individual, but we have to make the agreement with the corporate Page 24

П

entity. It's a little different than being an individual homeowner and that's why I'm saying what I'm saying.

We have to know, this Board -- in other words, how many residents are there now?

MR. ADAMO: There's about 400.

MR. HANLEY: All those 400 people when they act in a way that impacts that real estate, they have to act through the Association. You do not have the legal authority to act on your own in that regard, unlike someone who owns a free standing residence, which I'm sure you --

MR. ADAMO: Well, I can honestly say, rather than have 100 people barge into the office or 200 people, I've had many conversations with many, many residents up there, inasmuch as I'm retired, a lot of them are still working and they chose me as the --

MR. HANLEY: We need that representation from whoever is the official chief executive of the -- there's got to be a chief executive person.

You elect a Board, correct.

MR. ADAMO: Yes, we do.

MR. HANLEY: That individual, the Board needs to vote on this proposal and that person needs to send us a letter indicating that they are officially represented. And the Association has to have a lawyer.
