MR. AMODIO: On the roll.

(Roll call was taken, all Commissioners present respond in the affirmative)

MR. AMODIO: Time is 9:46.

You have a quorum.

PRESIDENT DeVITA: Just for the record,

Commissioner Bazian phoned me, he told me he had a
slight emergency. He will be here.

MR. AMODIO: Commissioner Rodriguez is also on her way.

All of the requirements of the Open Public Meetings Act have been met. Commission meeting notice have been furnished to all Commissioners, city clerks of Paterson, Passaic, and Clifton, North Jersey Herald News, The Record Passaic County edition and the Commission's executive staff with a copy posted on the main bulletin board of the Clifton facility.

Will you please rise.

Commissioner Levine, will you please lead us in the Pledge of Allegiance?

I don't believe there's anyone from the public who's here who wishes to be heard.

If you like, we can go right into committee reports.

PRESIDENT DeVITA: Let's go.

MR. AMODIO: First item.

PRESIDENT DeVITA: Personnel, Bob.

COMMISSIONER VANNOY: Personnel, hopefully we can finish up our Table today. You know, as far as it goes, feedback and everything to where our last personnel meeting we were comfortable Page 2

with the way it was and the other four are, or at least one of the four.

PRESIDENT DeVITA: We haven't gotten any comments or feedback.

COMMISSIONER VANNOY: I actually spoke to Commissioner Rodriguez. She was okay. If you have any questions, we'll bring it up at that point.

PRESIDENT DEVITA: Can we vote on it now?

COMMISSIONER KOLODZIEJ: I just have a question.

Changes on the Table of Organization, my suggestion last time based on my experience, my function with complying with the recommendation

that Mr. Bella has made in regard to moving that one function to the Engineering Department. My only concern was the creation of another position, and I really haven't looked at your corrected copy, and having two people with the same job title.

And if you read the minutes back, you'll see that my concern was the person's new title basically doesn't reflect the job that he has been doing for us. So if that's the case, is he vacating the job that he used to do for us and now will take on the new function, which is the same function as someone else has had for a long time. So that's my only concern.

Everything else on the table was fine with Page 3

So it's the one position, and as I stated for the record last time, the job description, in my opinion, should match the job that you do. And if this employee is so multi-talented that he could do both tasks, in my experience, he's not going to be able to keep both titles. The title should reflect the main part of the job that that person is doing.

COMMISSIONER LEVINE: You have to see if he's allowed to do both.

COMMISSIONER KOLODZIEJ: Well, there is a waiver. However, again, the waiver has to be based on basically the majority of what that person specifically does.

COMMISSIONER LEVINE: And also if he leaves, if you hire somebody and something happens, he retires, what about when the new person comes in? We lose that, you know.

PRESIDENT DeVITA: I think what we had done in personnel is, we had gotten a job description from Jim Gallagher.

COMMISSIONER KOLODZIEJ: All right. So by the time we vote on that, can you give me that job description?

COMMISSIONER VANNOY: Any further discussion?

COMMISSIONER KOLODZIEJ: But that's the only thing that I have is that one position. So if we can somehow adopt the Table, unless I'm the only one that needs the clarification. I could go Page 4

right to Civil Service and get the clarifications. I don't need it from you. So I would have to abstain if that position is not made clear to me as to what title correctly belongs with how that employee --

PRESIDENT DeVITA: So we can get that from Jim?

COMMISSIONER VANNOY: Right.

PRESIDENT DEVITA: All right.

(Commissioners Rodriguez and Bazian are present at 9:53)

COMMISSIONER VANNOY: There are new hires but they are not mandatory. But we'll discuss that as well.

COMMISSIONER KOLODZIEJ: They're on our agenda today? And, again, the Engineering Department and outside consultants and I am pleased that one of the recommendations is --

COMMISSIONER VANNOY: We try.

COMMISSIONER KOLODZIEJ: A plus.

COMMISSIONER VANNOY: One personnel issue that we'll discuss in closed session.

MR. HANLEY: Is that the Rice notice? Is it necessary? Is it an individual?

COMMISSIONER VANNOY: Two.

individuals are going to be discussed, they need to be Rice noticed in advance.

COMMISSIONER RODRIGUEZ: We should have.

PRESIDENT DeVITA: Don't tell us out loud.

COMMISSIONER VANNOY: Yeah, I know. The
two that we just talked about.

PRESIDENT DeVITA: Let me see if it's in my notes.

COMMISSIONER KOLODZIEJ: The advice is and certainly, I don't intend to mention any names --

PRESIDENT DeVITA: Do we need to mention names? We're not going to mention names.

MR. HANLEY: If it's conceptional and if it has to do with the things that has to do with an impact on potential grievances or collective bargaining, then you can do it in closed session so long as you don't name names.

PRESIDENT DeVITA: Right.

COMMISSIONER KOLODZIEJ: I don't intend to name names. It's conceptional. I know what the former T.O. had in regard to the duties performed by one of these people, but now that person will have a new title and I'm supposed to get a job description here of what the new title is; so.

COMMISSIONER VANNOY: Are we back on

who the other individual is. But the individual I want to talk, it's not an individual. I mean, Commissioner Levine is absolutely right. This is a position that this organization needs, which do I need more? What I know this position has been doing or is this the job description?

COMMISSIONER LEVINE: It's a conflict of interest.

COMMISSIONER KOLODZIEJ: The job title basically is based on the majority of how that employee's time is used.

COMMISSIONER LEVINE: My understanding -COMMISSIONER KOLODZIEJ: And Civil
Service.

COMMISSIONER LEVINE: My understanding is they can do both.

COMMISSIONER KOLODZIEJ: Right. And if they do do both, what title will they be given. Like we said at the last meeting, Civil Service, a lot of titles are obsolete. This is all they have. So you really don't have a choice. You have to fit them in and the way Civil Service will fit them in.

COMMISSIONER LEVINE: I understand Civil Service, can they do the other job with the new title? That's my --

COMMISSIONER KOLODZIEJ: No, not without --

PRESIDENT DeVITA: Let's talk about it,

PRESIDENT DeVITA: No, I mean the Table of Organization.

PRESIDENT DeVITA: No, no, I'm saying the Table of Organization, we don't have to Rice notice.

MR. HANLEY: Then it may be that you should do it in closed as well. That's another issue, depending on the facts.

PRESIDENT DeVITA: We'll go over that.

MR. AMODIO: Carry that.

PRESIDENT DeVITA: Okay.

MR. AMODIO: Finance.

COMMISSIONER LEVINE: We didn't have a meeting because the holiday was every...

COMMISSIONER KOLODZIEJ: True.

COMMISSIONER LEVINE: This month, the majority of our Commission is the holiday.

There was nothing pertinent.

PRESIDENT DeVITA: Nothing to report?

COMMISSIONER LEVINE: No.

PRESIDENT DeVITA: Okay. IT/Security.

COMMISSIONER KOLODZIEJ: Security, we have Page 8

a proposal back before us and we all kind of picked up on the fact that the proposal before us is actually more expensive. However, there's two things you need to consider. This organization is a critical infrastructure facility and requires, in my opinion, the best security we can get at the best price.

The contract, if I read it correctly, Mr. Hanley, is an up to amount. The Sheriff is trying very hard to do what a private security company would do to use retired trained officers to fill some of the positions. Until that can be figured out with the union, right now these numbers are based on using active Sheriff's Officers.

I don't want to go into the details because I think contractually we can.

MR. HANLEY: I don't think I've seen that.

COMMISSIONER KOLODZIEJ: We all got it
last meeting. We all got it last meeting.

COMMISSIONER RODRIGUEZ: We did.

COMMISSIONER KOLODZIEJ: But, anyway, I think because it's contractual, that's the overview. We have the committee. I guess I was the only one that attended that meeting. The only other option we have was to use an outside security firm and I did sit through one that was from New York, certainly capable; has a history with this organization. But the reason they can make the bottom numbers appear better is because

they intend to use retired public safety officers.

PRESIDENT DeVITA: Can I comment?

COMMISSIONER KOLODZIEJ: Yes.

PRESIDENT DeVITA: The problem I have is George hasn't seen this contract.

MR. HANLEY: Apparently, it was in the packet, but I didn't.

PRESIDENT DeVITA: I'm going to assume we need you to go through this before we go much further.

The issue I have is the pricing that we have is not with the retired people.

COMMISSIONER KOLODZIEJ: Correct.

PRESIDENT DeVITA: So I don't know what it's going to cost.

COMMISSIONER KOLODZIEJ: However, however, at any point in time when the Sheriff, you know, can iron out that detail. We deal with unions here so we basically know, then he can basically substitute any one of the existing personnel with those.

And there's two things that you need to keep in your head. Commissioner Vannoy, you've been on top of this for two years.

The outside coverage is essential, because even if we hire an outside firm, they cannot do arrests on the spot. They have to call in the local or the Sheriff or whoever they're going to call in. They can detain the perpetrator. So because of our facilities, you know, just makes Page 10

sense. And if you look at the proposal, very wisely the Sheriff has put the, whoever covers that sector and whatever city it is, will now have the full responsibility for treating ours like they treat anybody else's.

The inside facility is a different situation. We're a closed facility. We're working on the IT with badges and better security there and anything you can do in that respect will enable us to change and Mr. Bella had just given me a suggestion before the meeting which I'll do in closed session.

So that's basically where you would use the retired people.

COMMISSIONER VANNOY: Do we know the difference between regular Sheriff's Officers and retired, pay wise?

COMMISSIONER KOLODZIEJ: Oh, big difference. Big difference.

PRESIDENT DEVITA: We don't have it.

COMMISSIONER KOLODZIEJ: Big difference.

COMMISSIONER LEVINE: They can do the arrest inside the buildings.

COMMISSIONER KOLODZIEJ: Our Sheriff's Officer, absolutely they can.

COMMISSIONER VANNOY: Even the retired officers can still do --

COMMISSIONER KOLODZIEJ: No, they can't make arrests.

percent sure about that?

COMMISSIONER KOLODZIEJ: I'm a hundred percent sure. They're retired.

PRESIDENT DEVITA: One at a time. One at a time.

How many arrests have we had in the last couple of years on our outside facility?

MR. BELLA: I don't know off the top of my head, there have been.

COMMISSIONER LEVINE: Have there been any?

MR. BELLA: Yeah.

PRESIDENT DeVITA: For what?

MR. BELLA: Trespassing on the reservoirs. One was a pretty big case, you know, the guy had a gun and stuff like that.

COMMISSIONER KOLODZIEJ: I would like to,
I kind of think what I'm hearing, especially from
my colleague from Clifton that we've been talking
about this for two weeks. It's not that we
disagree, your points are well taken. So I think
I have a suggestion in the closed session that
we'll more or less go back to the Sheriff and say,
you know, this is what we would like to do and go
from there.

COMMISSIONER LEVINE: I'd like to have at

least one police, regular real Sheriff's Officer there.

COMMISSIONER KOLODZIEJ: Let's do that in the closed session.

PRESIDENT DeVITA: Let's give George a chance to review it.

COMMISSIONER VANNOY: One more question.

If we hire retired Sheriff's Officers and they're
part of that contract, doesn't that make them real
workers at that point?

I'm only asking because I talked to a retired Sheriff's Officer, he said they were.

COMMISSIONER KOLODZIEJ: Well, Mr. Hanley will reaffirm that.

MR. HANLEY: Will reaffirm what?

COMMISSIONER KOLODZIEJ: If we wind up using, you know, a retired, you know, through the Sheriff's Office, what I see and, Joe, correct me if I'm wrong, what I see in the difference with this last proposal over the first proposal is the Freeholders are involved in this contract. It's going through them. Because as George has pointed out many times, we can't contract with the Sheriff separately; so.

MR. HANLEY: That's always the way.

COMMISSIONER KOLODZIEJ: Right. To me this is another step in what I consider shared services. We're doing it with the Prosecutor's Office with the Dark Fiber. We're doing it in my opinion, through the Freeholders and using this. And I guess what you have to weigh is an outside

pvwc101911.txt firm is easily able to hire a bunch of retired people.

Our Sheriff, if he's able to get his union to agree to that, would be using retired officers from our local PDs; Passaic, Paterson, Clifton, Little Falls, whoever. And that's one of the statements he made. That as he's able to, especially as Commissioner DeVita has pointed out, in those facilities where that would be desirable rather than somebody getting paid this much an hour, that's what he would like to do.

COMMISSIONER VANNOY: Are they able to carry a gun?

COMMISSIONER KOLODZIEJ: No, they're retired. They're retired. If they're registered, yes. They cannot make arrests and point the gun at you. They still have to call Clifton or Paterson or whoever.

PRESIDENT DeVITA: Guys, let's do one at a

time so she can get this.

COMMISSIONER KOLODZIEJ: Anyway, you got the concept. You certainly know what Commissioner DeVita's, and I respect it, because he's right, you know, about the cost factor, but you have to weigh, you know, what kind of security we need and what you think is a fair price for that security.

COMMISSIONER BAZIAN: Not much to report, with my holiday schedule, IT was not really able to meet. I did have a discussion with Commissioner Vannoy, because I had raised a concern regarding the --

COMMISSIONER BAZIAN: In general with regards to the copiers that we were getting. I had some concerns, especially with regards to disposal.

I don't know if you're all aware, but the copiers today, all the hard drives and any time you're making a copy of something, it's stored on the hard drive and when you get rid of a copier, you need to either reformat or otherwise Degauss or otherwise destroy --

COMMISSIONER BAZIAN: Yeah, D-e-g-a-u-s-s.

COMMISSIONER VANNOY: Believe it, it's a

Basically, you take the hard drive and test it through a magnetic field and swipe it through. That's what it is. It's just a means of

PRESIDENT DeVITA: You can erase.

COMMISSIONER VANNOY: I actually talked to Louie and I made sure that the old copiers, we would actually take the hard drives out ourselves. We can give them to our IT people. Those are actually our copiers anyway, so it's not like we have to return them. We can destroy them.

PRESIDENT DeVITA: We can Degauss them ourselves.

MR. AMODIO: That will be for their contract. It will be in an additional.

MR. GALLAGHER: We have an outside company that's going to do that. They're coming on-site. I never heard the term Degauss, but, yes, that's what is going to happen.

I learned a new word for today.

PRESIDENT DeVITA: All right. That's it?

COMMISSIONER BAZIAN: There was also a

concern raised, I had asked, I was unaware of

pricing and I know it's a State contract, but how

does that compare to others? Again, I had a

discussion with Commissioner Vannoy. I only

mention Commissioner Vannoy because if my area is

IT, his is copiers and he knows this stuff. And

based on the conversation I had with him, I'm cool

with this to go forward. So that's pretty much

all that's happened.

There's a lot to be done and that will happen in the next month moving forward.

COMMISSIONER VANNOY: One more thing. I had raised the question of the copiers and everything is all right. We just have to change the purchase order make it out to the company that sell, the manufacturers.

PRESIDENT DeVITA: So all of your concerns that you had are resolved?

COMMISSIONER VANNOY: Yes.

PRESIDENT DeVITA: Is that it now?

COMMISSIONER VANNOY: No. One more thing on personnel.

Contract negotiations, the three

Commissioners, Tom, myself, and Rigo. We're going
to attend the next contract negotiation meeting so
we'll be able to give you at least an update.

PRESIDENT DEVITA: All right. League of Municipalities. I had asked that to be put on the agenda. I would like to see, I think the people that should probably go to the League of Municipalities are probably the department heads. Louie gave me a list of what sessions there are. There's things in financing and purchasing, all kinds of stuff.

I would like to see our department heads and Joe, you're the head guy to see who should go.

Probably get some certification points. Linda could get some information.

So I would like to see, as opposed to Commissioners going down for two or three days, I'd like to see our personnel go down who could really benefit from it.

Anybody have any problem with that? I don't know what budget we have for that.

COMMISSIONER BAZIAN: If I may, just as a comment.

One of the concerns I have generally, things like the League of Municipalities, reputationally the League of Municipalities is a three or four day holiday fest.

(Whereupon, Commissioner Sanchez is present at 10:08)

PRESIDENT DeVITA: Shouldn't be.

COMMISSIONER BAZIAN: It shouldn't be. I have no objection to sending people down, assuming that they have an agenda of things that they are going to attend and they can come back and report on what they have attended.

I think we should also be engaged by a

simple cost versus benefit, by which I mean, if
we're going to send somebody down and we're going
Page 18

to send them down for multiple days, we now have to incur an overnight charge, perhaps for lodging or whatever it might be. I think that that's something that needs to be carefully monitored. I rely on Joe to do so; but.

PRESIDENT DeVITA: I agree with you. I think that as opposed to Commissioners going for three days, as some have in the past, there's no real need for that. You know, you can get what you want out of the League, that's fine. If you want to go for a day, okay. But I would rather see our department heads go that can come back and report.

You guys didn't know Commissioner Grecco.

He was the master. Whenever he went, he came back and he had a report for us on everything he went to, what he learned, and what he did. And that's what we should do.

COMMISSIONER LEVINE: I disagree on that because every year I've gone down there, my committee, whether I'm doing IT or finance, we found a phone guy, you know, that you can, you know, actually, you know, bring in the quoting

process. I met people from the AWA that I met, made contacts with. There's certain things I'm looking to switch, like the cars, the trucks. I met those people in the AWA so the logic costs for one day \$260 saves the Commission, where a department head --

PRESIDENT DEVITA: I don't have a problem with that.

COMMISSIONER LEVINE: Where a department head doesn't have the interest like we do to actually save the money or do whatever. And even if we don't, you know, go for the whole time or something, but you do meet a lot of people that can bring, you know, better qualities to the Water Commission from south Jersey, you know. Different RFP people that we can hand out that didn't know we even did these RFPs. They didn't know how to find the list.

PRESIDENT DeVITA: I'm not saying Commissioners shouldn't go at all.

COMMISSIONER LEVINE: People do take advantage.

PRESIDENT DeVITA: Absolutely.

COMMISSIONER LEVINE: I want to avoid the taking advantage of. But I think people in their

own committee, like the IT committee get a lot out of it. If I knew what I was doing, you know, knew the IT like Menachem did, you can get a lot more out of it.

COMMISSIONER KOLODZIEJ: Can I make a suggestion?

Just listening, obviously, this begs for a policy, a new policy, because we don't have one. We have loosely whatever we did.

And by the way, Mr. Grecco, he was a product of Clifton's policy. Because we got tired Page 20

of people just going down there and say, okay, you think you learned something, what did you learn.

So I would like to implore, if your community has a policy, I know Clifton does, and then come back with a suggestion then we can fine tune.

COMMISSIONER RODRIGUEZ: Paterson has that. Anybody that goes has to come back -- well, currently, I don't know. Under the former administration, anybody who went had to come back and give the Mayor a report.

COMMISSIONER KOLODZIEJ: I'll take the best of what's out there. My own feeling is, yes, this is basically for -- it is a plus, especially

for engineering and departments where you can get credits for going to some of those seminars. But, my only feeling is, we should have representation from this body of ours, whether it be the President or somebody else. If the President doesn't want to go, then somebody else can step in and go. In my opinion we need that visibility down there to have your policy makers mingling with all of the other people, but do I think all seven of us need to go? No.

So let me give a crack at establishing some sort of policy and then we can pick it apart and put in and take out of what we think.

COMMISSIONER RODRIGUEZ: I like that.

PRESIDENT DeVITA: Now, the League

COMMISSIONER SANCHEZ: Can I? Can I? I apologize for being late.

May I say something?

PRESIDENT DeVITA: You certainly can.

COMMISSIONER SANCHEZ: Is there any way we can come up with like a specific seminar for the people that are going? We could do that ahead. I mean, we could send, this seminar is going to be... So we can pick the seminar and the people

PRESIDENT DeVITA: I'm sorry if you have trouble understanding my English. I'm sorry.

COMMISSIONER SANCHEZ: I'm saying it the right way.

PRESIDENT DeVITA: You're right. There's a list. Louie gave it to me. Joe, you could go over it with people, see who is going to what.

Make sure we get the proper attendance, the proper feedback from our people. Okay.

MR. BELLA: Okay. I'll do that.

PRESIDENT DeVITA: All right.

MR. BELLA: Yes.

COMMISSIONER BAZIAN: I'm going to ask a question, if it's inappropriate, I'm going to ask Page 22

my fellow Commissioners to just bear with me.

But one of the things that I think is important from a transparency point of view is that any request to go to something like this, especially if it involves an overnight stay,

27

should go through more than one hand, for two reasons. One is, if Commissioners are individually booking, I'm going to this, I'm going to go to that, whatever, we may have duplication. We may have people going to certain places that are already covered. Some coordination I think would be a good thing.

The second thing I think also would be appropriate is that every request go through the presidency or committee or whatever. I don't know if we can do it for this year given the short time, but just like a department head who wants to do things, theoretically, has to get it approved or should have it approved by the Executive Director before they go, I think the Commissioners should be subjected to the same thing, just for the purposes of transparency. We should not be able to say, hey, I can theoretically pick one seminar on all three or four or however many days and be down there for four days and have a good time. I don't think any of us would do that, but the issue of transparency doesn't deal with what we would do but what we could do. And that's a question that I'm posing to see what the group...

COMMISSIONER KOLODZIEJ: That would be incorporated into the policy.

COMMISSIONER BAZIAN: That would be incorporated into the policy.

COMMISSIONER KOLODZIEJ: You're saying that employees would have to be approved by Mr. Bella. Anybody going from this body would have to be approved by us.

incorporate that into the policy, putting a ceiling on expenses. Because some places, City of Clifton, you want to go to a convention, Councilman or Mayor, you pay your own way. However, if you put a ceiling on it, and we had this discussion last year when we got those bills when people going out to dinner here, when they could have gone out to dinner there. Those are the kinds of things, in my opinion, that our policy needs to be addressed. This is how much we're paying. If you want to go above that, it's going to cost you.

The policy idea is a good idea.

I want to tell Jeff, there is, and it's Page 24

time consuming and it's a little more costly, but for any Commissioner who's never been, because you don't need to go every year, but for any Commissioner who's never been, and this is separate and apart from the League of Municipalities, is the national thing. Because if you're going to work on policy, that should be, and there should be a policy for wherever any personnel -- just like, like I've always said, we're kind of quasi-public when it's convenient for us. But there should be a policy, the League, I'm not going to talk either way, I go. I go all the time, it doesn't matter, with this entity, with another entity, with my firm. Besides and above, I like the idea of Finance and I like the idea of Purchasing going, because I think there's a lot there.
