 - a) Contract No. 21-B-24 "Discharge Piping Modifications for the Hydrocyclone System" Recommendation to award a One (1) Year Contract to Allied Construction Group, of Parlin, N.J. in the amount of \$227,000.00

b) Shared Services Agreement with Passaic County Regarding Storm Sewer Encroachment Issue on Valley Road and Robin Hood Road, Clifton

It was discovered during the NJDOT Route 3/46 Contract B project that Passaic County's storm sewer encroaches on PVWC's 51-inch steel transmission main on Valley Road at Robinhood Rd. It is recommended that we enter into a shared services agreement (50%/50%) with Passaic County to correct an storm sewer encroachment issue. Passaic County received a quotation for conducting this work through their contractor, Online Contracting, Inc. in the amount not to exceed \$200,000. The NJDOT's contractor, Union Paving provided to the county a cost proposal of at least \$250,000, with additional time and material items that were included in Online Contracting's proposal. In the effort to minimize costs, PVWC will provide about 160 LF of CL54 ductile iron pipe and gaskets and will allow the county's contractor to dump the spoils at the Great Notch Soil Transfer Site to be disposed of by the Commission. PVWC's share not to exceed \$100,000 plus in-stock inventory items and disposal of trench spoils associated with PVWC's existing trench spoils disposal contract under Contract 19-B-18.

c) Shared Services Agreement with Borough of Lodi Regarding Paving Various Streets Associated with Main Replacement Work

The Commission asked the Borough to postpone their plan to pave several roads in the Marion Pepe Drive area following work done by PSE&G so that PVWC would be able to replace severely deteriorated cast iron mains. The Borough agreed however they are now requesting a cost sharing agreement. It is recommended that we enter into a shared services agreement with the Borough of Lodi to resurface various roads within the Borough associated with our recent water main replacement contract. PVWC would use our existing pavement restoration contract with D&L where PVWC would receive credit from the Borough for 45% of the restoration costs (about \$61,000). Total estimated cost of the restoration project is approximately \$135,000. PVWC's share is approximately \$74,000. The total amount will be deducted from PVWC's existing pavement restoration contract under Contract 20-B-17.
