RESOLUTION OF PASSAIC VALLEY WATER COMMISSION

**AUTHORIZING THE PROCUREMENT OF ADDITIONAL HYDRA-**STOP EQUIPMENT AND INSERTION VALVES"

**DATE OF ADOPTION: MAY 24, 2023**

WHEREAS, the Passaic Valley Water Commission ("PVWC") wishes to procure additional Hydra-Stop ("Hydra-Stop") equipment for installing 12-inch insertion valves and to procure 6-inch, 8-inch and 12inch insertion valves for the Distribution Department to replace the existing valves that are damaged beyond repair under the proprietary goods exception to the Local Public Contracts Law ("LPCL"); and

WHEREAS, Hydra-Stop of Burr Ridge, Illinois ("Hydra-Stop") has provided PVWC with pricing sheet and the Distribution Department has determined their immediate need to be in the total amount of \$895,244.20, to procure the new equipment; and

WHEREAS, Hydra-Stop is the sole provider of Hydra-Stop insertion valves, as demonstrated by the Sole Source letter attached hereto as **Exhibit A**, which allows the user to replace valves that are leaking and beyond repair at the site and avoid the disruption to the customer in shutting down an entire block to replace one valve; and

WHEREAS, the Hydra-Stop equipment allows the Distribution Department to optimize valve replacement of old and leaky valves without shutting down water service to an entire block and instead isolate the repair to minimize the impact on its customers; and

WHEREAS, the LPCL normally requires Contracting Units to give bidders the option to supply "equivalent" equipment to the brand name specified as per N.J.S.A. § 40A:11-13(d), N.J.A.C. § 5:34-9.2; and

WHEREAS, the LPCL allows Contracting Units, in appropriate situations, to designate certain brands of goods as "proprietary" when those brands of goods are "necessary for the conduct of [the Contracting Unit's] affairs" (hereinafter "the Proprietary Goods Exception") (see N.J.S.A. § 40A:11-2(39); N.J.A.C. § 5:34-9.1(a)(2)); and

WHEREAS, the Proprietary Goods Exception provides that if the Contracting Unit needs to procure goods "of a specialized nature" by one manufacturer, and the need for a certain brand is greater (or more valuable) than the "public benefit of permitting brand name or equivalent, the Contracting Unit may proceed with a bid specification that restricts bidders to supplying just that brand name of goods, to the exclusion of others; and

WHEREAS, a Contracting Unit may be entitled to opt for the Proprietary Goods Exception when: (i) The contracting unit has a substantial investment in facilities, training, replacement parts, or complimentary items that warrants reliance on a specific manufacturer or vendor to maintain the value of the investment, and/or (ii) Unique circumstances as to a facility or environment preclude the use of other goods or services; and

WHEREAS, in accordance with the pre-requisite procedures for entitlement to use the Proprietary Goods Exception, the PVWC's Buyer, Lisa Bresemann, has prepared a Certification addressed to the Executive Director, General Counsel, and Chief Financial Officer to demonstrate entitlement to use the Proprietary Goods Exception, which is attached hereto as Exhibit B, the contents of which are deemed incorporated into this Resolution as set forth herein; and

WHEREAS, the Executive Director, General Counsel, and Chief Financial Officer reviewed the Certification and concur with the findings of the Buyer and ask the Commissioners to authorized PVWC to designate the Hydra-Stop equipment as proprietary goods henceforth; and

**WHEREAS,** PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and said certificate is attached hereto as **Exhibit C**; and

**WHEREAS,** Hydra-Stop's price sheet and other relevant correspondences are attached hereto as **Exhibit D**; and

**WHEREAS,** the Commissioners, having received the aforementioned Certification and recommendation, approve the above-referenced measures; and

NOW, THEREFORE, BE IT RESOLVED, by the Passaic Valley Water Commission, in the County of Passaic, New Jersey;

- 1. That the Commissioners, in accordance with recommendations referenced above, hereby authorize PVWC to procure the Hydra-Stop Equipment and Insertion Valves under the Proprietary Goods Exception to the Local Public Contracts Law.
- 2. That appropriate officials and employees of the PVWC are hereby directed to procure the Hydra-Stop Equipment and Insertion Valves in accordance with these findings and applicable law, and to perform such acts and executes such documents as are necessary to implement the terms and intentions of this Resolution as set forth hereinabove.



## RE: Procurement of Additional Hydra-Stop Equipment and Insertion Valves

- 1. I, Lisa Bresemann, QPA, serve as the Buyer and am the Qualified Purchasing Agent for the Passaic Valley Water Commission ("PVWC").
- 2. I make this Certification pursuant to N.J.A.C. § 5:34-9.1 in support of the PVWC's position that PVWC is permitted to procure from the Original Equipment Manufacturer (OEM), Hydra-Stop ("Hydra-Stop"), additional Hydra-Stop Equipment and Insertion Valves for use by the PVWC Distribution Department as proprietary goods as that term is defined by N.J.S.A. § 40A:11-2(39).
- 3. Currently, PVWC procures insertion valves and replacement equipment from Hydra-Stop without regard to brand, or by allowing "or equal" as per N.J.S.A. § 40A:11-13(d) of the Local Public Contracts Law.
- 4. Hydra-Stop has provided a letter, dated April 27, 2023, that is on file in the PVWC Buyer's office, verifying that Hydra-Stop is the sole provider of Hydra-Stop Insertion Valves and Equipment and this equipment will insure that PVWC's broken and leaky valves which are damaged beyond repair may be replaced in a manner beneficial to the public safety welfare, so that an entire street does not have to be shut down in order to replace a broken and leaky valve, thereby benefitting the customers of PVWC.
- 5. I, as the PVWC Buyer recommends that the Board of Commissioners approve a Resolution authorizing the PVWC to procure the Hydra-Stop Equipment and Insertion Valves as proprietary goods.
