WHEREAS, PVWC awarded Award Contract No. 22-B-14 entitled "Emergency Water

Main Repairs" (the "Contract") to J. Fletcher Creamer & Sons, Inc. ("Creamer") of Hackensack,

New Jersey at PVWC's Commission Meeting on June 22, 2022, not to exceed \$4,108,513.00

under Resolution No. 22-066; and

WHEREAS, Proposed Change Order No. 1 is to cover out-of-scope emergency work

for locating leak on multiples and installation of a structural liner on four (4) of the failed /

problematic water mains crossing the Passaic River at Belleville and Kearny, with a total

increase of \$1,250,000.00 (30.4% increase) which brings the total adjusted Contract Price

up to \$5,358,513.00; and

WHEREAS, the Director of Engineering has reviewed Creamer's Proposals attached

hereto as **Exhibit A** and emergency expenditures already performed by Creamer and found

it to be reasonable, considering the nature and scope of additional Work involved, and has

recommended that the said changes to the Project, and additional costs related thereto, be

approved, and a copy of the Director of Engineering's memorandum dated May 18, 2023

recommending approval of the said changes to the Project is attached hereto and made a

part hereof as Exhibit B; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are

currently available for said purpose and a copy of the said certification is attached hereto and

made a part hereof as **Exhibit C**.

- 3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.

Re: Change Order No. 1 for Contract No. 22-B-14 entitled "Emergency Water Main

Repairs" - Emergency Repairs of the Kearny Multiples

It is recommended that, under Contract No. 22-B-14, J. Fletcher Creamer & Sons, Inc. ("Creamer") be awarded an increase of \$1,250,000.00 (30.4% increase) which brings the total adjusted Contract Price up to \$5,358,513.00 to cover out-of-scope emergency work for locating leak on multiples and installation of a 10-inch diameter Primus structural liner on four (4) of the failed / problematic water mains crossing the Passaic River at Belleville and Kearny. The Primus structural liners will be guaranteed for five (5) years and has a design life of 50 to 100 years. These multiples are crucial in conveying water from PVWC's main system to the PVWC's North Arlington system and wholesale customers which include Harrison and Lyndhurst.

Due to the fact that the Kearny multiples are currently located in a highly difficult location making accessibility challenging and due to soil contamination issues on the Kearny side of the Passaic River, PVWC will proceed with hiring a firm to conduct a feasibility study to identify alternate routes for a new river crossing and design a more permanent solution that has higher hydraulic capacity and easier maintenance that would be constructed within the next 6 years.
